

**PRE-INJURY WAIVER AND RELEASE OF
LIABILITY FORM**

In consideration for me being permitted to participate in any activities and/or attend any events coordinated or sponsored by Net Media LLC dba Citrus Ball (the "League") at Lecom Park, Bradenton, Manatee County, Florida, or any other locations associated with the underlying activities or events (the "Locations"), as well as use any transportation provided therein, I agree to the following Pre-Injury Waiver and Release of Liability. I hereby assume all of the risks of participating in or attending the activities or events, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability with or without fault.

I acknowledge that this Pre-Injury Waiver and Release of Liability Form will be used by the event holders, producers, sponsors and/or organizers of the activities or events in which I may participate in or attend.

I WAIVE, RELEASE AND DISCHARGE from any and all liability, including but not limited to liability arising from the negligence or fault of the entities released, for me or my child's death, disability, personal injury, property damage, property theft or actions of any kind which may occur by me or my child participating in or attending the activities or events. The Florida State League of Professional Baseball Clubs, Inc. and its member teams, including any team affiliated or associated with the above in any way, any entity that has any ownership or financial interest in the location above, the Pittsburgh Pirates or any affiliated team or entity, Manatee County and the City of Bradenton are hereby covered by this Pre-Injury Waiver and Release of Liability. In addition, all partners, owners, directors, officers, employees, representatives, agents, volunteers and parent, affiliated and subsidiary entities of the aforementioned parties are covered by this Pre-Injury Waiver and Release of Liability. The undersigned further agrees to save and hold harmless and indemnify each and all of the parties referred to above from all liability, loss, cost, claim or damage whatsoever which may be imposed upon said parties due to my or my child's participation in or attendance at the activities or events. This event is in no way sponsored or endorsed by the teams whose names appear in various location at the location above. Any of these teams encompassed in the preceding sentence are also incorporated into this liability waiver and release form.

I am physically fit to participate in or attend the activities or events and have not been advised otherwise by a medical practitioner. In connection with any injury, illness or other medical condition I may experience during the activities or events, I authorize any emergency medical assistance or treatment deemed necessary if I am not able to act on my own behalf.

I understand that at this event or related activities, I may be photographed or video recorded. I agree to allow my name, voice, photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and assigns.

I agree not to disclose any confidential or sensitive information that I may obtain during the activities or events. I agree to not publicly disparage any of the entities involved with the activities or events.

This Pre-Injury Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent allowable under Florida Law.

This Agreement shall be governed by the laws of the State of Florida. In the event of any action arising hereunder, venue shall be proper only in the state courts of Tampa, Hillsborough County, Florida.

**NOTICE AND WAIVER REGARDING VIRUS
